## WHY OMAN?

The Sultanate of Oman is enriched with varieties of mineral resources metallic minerals such as copper, gold, zinc, chromites, cobalt and iron ores and non-metallic minerals includes, dolomite, limestone, gypsum, calys, silica, ornamental stones and building materials. Several mining companies have grown based on these mineral commodities, which participate as a part of the national development sector and contribute to the nation's GDP as well as providing jobs for Omanis.

Copper has been mined in Oman for thousands of years. Recently Oman Mining Company and Mawarid Resources mining about 35 million tons of copper ores from Sohar and Shinas areas. In addition four new companies granted exploration licenses for developing copper mining projects in Al-Batinah coast. There are more than 15 companies mining marble stone from different quarries in the northern mountains of Oman. Gypsum, limestone and clay are also mined from Oman for export and as local supply raw materials for different industries. Other mineral resources, which are recently evaluated such as, copper ores, clays and silica sand are also showing economical feasibility and can be exploitable for several years.

Four new companies were recently granted exploration licenses for developing copper mining projects on the AI Batinah projects.

## MARKET FACTS:

- Oman is the second largest country in the GCC region with an excellent geology of minerals.
- Oman's mining industry is set to become an important sector in the country's diversification program.
- Oman is the first GCC producer and exporter of ferrochrome.
- Oman is home to sizeable deposits of limestone, marble and other carbonate-based minerals.
- The discovery of immense deposits of chromite has attracted significant investments over the last few years.
- The Mining Law and Implementing Regulations provide for several different types of licences, which are split between exploration and prospecting licences and longer-term extraction concessions.
- Applications for all types of mining permits are subject to consideration of safety and environmental concerns and the potential effect on Oman's water resources and archaeological heritage.

## KEY MINING PROJECTS IN OMAN

#### Block 4, 5, 6 Copper Mining Projects



The exploration of a targeted 10,700,000 and 29,250,000 tons of 1.4 and 2.4 per cent copper in the Semil Ophiolite Belt in northern Oman and the development of gold and copper deposits from a central operating plant.

#### Washihi Copper-Gold Project



The construction of a commercial open pit mine in Oman's Washihi locality, 160 kilometers southeast of Muscat. It involves the commercialization/processing of copper deposits with associated gold ore, which cover a total area of about 105 square kilometers. It is expected to produce 77,000 tons of copper and 18,000 tons of gold yearly upon operation. Expected revenues amount to US\$ 434 million over a period of 10 years.

**Duqm Mineral Concessions** 



The usage by mining companies of Duqm Port's 300-meter dedicated break bulk terminal to export their minerals, including limestone to several countries. The terminal has a capacity of up to 5 million tons per annum. The first shipment of dolomite from the port's commercial quay was done in February 2016.

Project Cost: US\$ 50 million

# **MARKET** LANDSCAPE:





Currently more than 300 mining operations are active out of which 53 are for chromite, 7 are for copper, 108 for aggregate, 31 for marble, 25 for building products, 7 for limestone, three each for sandstone and manganese, five each for gypsum, laterite and clay followed by one for salt and dune sand. In 2014, Oman exported its entire production of 2,300 tonnes of copper cathodes earning revenues of RO6.1mn.

During the period, production of marbles rose to 1.56mn tonnes valued at R021.7mn as against 1.25mn tonnes worth R018mn produced in 2013. The sultanate produced 8.72mn tonnes of limestone worth R09.9mn in 2014, with corresponding figures for 2013 being 5.48mn tonnes valued at R07.8mn. As much as 3.38mn tonnes of gypsum worth R05mn, and 751,200 tonne of chromite valued at R022.8mn were also produced in 2014. Laterite production reached 753,100 tonnes valued at R02.2mn while quartz production touched 282,900 tonnes worth R01.1mn. The sultanate produced 72,100 tonnes of copper worth R022.5mn and 37,500 tonnes of manganese worth R0417,800 while kaolin production exceeded 66,600 tonnes valued at R0199,800. Other minerals produced in 2014 include 12,900 tonnes of salt (R0451,000), 305,400 tonnes of mud (R01.6mn) and 60,200 tonnes of sand dune (R0150,500).

There are several major projects underway in Oman. Four concessions are planned to mine copper at Yanqul, Khaboura and Samad. The latest released data confirms that more than 40 Mt of copper ore has been proved available as reserves with 1% - 3% Cu. Feasibility studies for these four Copper Concessions are in the final stage. According to NCSI statistics, in 2014, the Sultanate produced minerals worth over R0142.2mn.

#### **Seabed Mining Operation**



A joint venture with a Canadian mining firm to wet test gigantic robotic machinery at Oman's Port of Duqm, which will be deployed on the seafloor to mine high-value minerals such as gold, copper, zinc and silver in the southwest Pacific. This project puts Oman as key base for the world's first seafloor mining project.

#### **Yangul Copper Project**



The exploration and development of five separate copper deposits in the Yanqul area in the northern part of Oman. The project is expected to support metal-based industrial projects in Oman and further support the government's diversification strategy to boost long-term investment opportunities in the infrastructure, power and mining sectors.


